1. Ordinary Assembly

The chair of the General Assembly, Bichara Khader, opened the session with a general statement on the historic importance of current developments in the region and EuroMeSCo's role in providing relevant research and analysis and in accompanying Arab democratic transitions.

a. Statement of the Secretariat on the state of the network, its activities and perspectives

The Coordinator of the Secretariat, Senén Florensa, expressed his condolences on behalf of EuroMeSCo for the recent loss of Alvaro de Vasconcelos' wife, Maria do Rosário de Moraes Vaz. Maria do Rosário was an active member of EuroMeSCo and Director of Programmes at the IEEI (Lisbon), and had been involved in Euro-Mediterranean research since the founding of the network.

Senén Florensa acknowledged EuroMeSCo's role as a provider of research excellence and a militant body contributing to the democratisation of the Arab world. Mr. Florensa reviewed the activities of EuroMeSCo in 2011 on the basis of the yearly report drafted by the Secretariat and presented to the Steering Committee. Among other pieces of information, the Coordinator of the Secretariat highlighted the work done on publications, research workshops, the annual conference, the network's website and the newsletter.



Senén Florensa also noted IEMed's financial commitment with EuroMeSCo, which amounts to at least 300.000 euros per year. He also stated that it is not likely to obtain resources by the European Commission to fund the network's activities in the near future.

The Chair of the General Assembly, Bichara Khader, transmitted to the Assembly the debates held in the Steering Committee regarding the scientific publications, the dissemination of the network's publications -also in international press- and the launch of another call for papers in the future. He underlined that EuroMeSCo will maintain previous practice to request academic papers to relevant researchers ahead of the Annual Conference.

The Chair also invited all members to jointly organise a conference or workshop with EuroMeSCo in order to strengthen the visibility of the network and to include EuroMeSCo's logo in the website of all member institutes.

b. Changes in the Secretariat and Coordinator

Senén Florensa introduced the new Coordinator of the Secretariat to the Assembly, following his appointment as Secretary of Foreign Affairs of the Generalitat de Catalunya. The new coordinator is Andreu Bassols, appointed Director General of IEMed in June 2011.

c. Work programme 2012

Andreu Bassols underlined the relevance of the EuroMeSCo network in light of political developments in the region. The democratisation processes require the analytical expertise and research excellence that EuroMeSCo provides. The network must also exercise major influence in policy-making in Europe and the Mediterranean region.

The work plan 2012 aims to consolidate the work done so far, in particular regarding research outputs and lines of publication. In 2012, the Secretariat plans to organise 3 research workshops in Brussels, Morocco and Egypt and would be pleased to count on institutes and analysts of southern Mediterranean countries for their organisation.

In addition, the Secretariat must reinforce the visibility of EuroMeSCo by improving the website and use of social media. Member institutes should include the EuroMeSCo logo in their own websites and EuroMeSCo institutes and researchers should be invited to participate in seminars and conferences organised by members of the network.

In 2012, EuroMeSCo will improve its work and mobilisation capacity, as well as its visibility and influence in policy-making, in order to become a leading forum for research on politics and security in the Mediterranean.

During the debate following the presentation of the work plan, several institutes underlined the need to work with youth organisations, to promote EuroMeSCo in national constituencies, to provide sound advice to policy-makers via short papers, direct interaction and meetings, to strengthen the EuroMeSCo communication tools and the website and to foster participation in international studies associations and foresee the organisation of graduate students' conferences or summer schools.



d. and e. Membership: Update and possible admissions and withdrawals

The focal point of the EuroMeSCo Secretariat, Pol Morillas, reviewed the state of play regarding demands for adhesion that have reached the Secretariat and suggestions for removal of member institutes on the basis of the measures foreseen in the statutes of the network (Article 4) and the failure to respond to calls of the Secretariat to fill in the EuroMeSCo membership form.

Such methodology was previously discussed and agreed at the Executive Committee meeting in April 2011 in Tunisia. The Steering Committee discussed and suggested the adoption of the following decision at the General Assembly following its meeting at IEMed on 5th October 2011.

Following a debate, the suggested decision was unanimously adopted at the General Assembly.

In addition, the General Assembly suggested that following the expression of interest by Fondazione Mediterraneo and Euromed Management to upgrade their status to full members of the network, this decision should be taken at the next General Assembly, when a formal letter of request by both institutes is sent to the Secretariat and subsequently discussed in the Steering Committee.

f. Minutes of the last meeting

The minutes of the previous General Assembly held in Barcelona on 19 November 2010 were approved.

2. Extraordinary Assembly

New article of the statutes on the Internal Evaluation of the Network's activities

The General Assembly, upon suggestion of the Steering Committee, agreed to introduce the following amendment to the statutes of the network (Article 17 on the functions of the Steering Committee).

Old version

Article 17

Steering Committee meetings are convened by the Secretariat. The main functions of the Steering Committee are the following:

- to establish the annual work and financial plans of EuroMeSCo and submit them to the General Assembly
- to submit to the General Assembly member or observer applications, based on reports on applications provided by a member of the network
- to appoint an Executive Committee and, if necessary, provide it with mandates Suggested Amendment of Article 17

New version

Article 17

Steering Committee meetings are convened by the Secretariat. The main functions of the Steering Committee are the following:

- to submit to the General Assembly a yearly report of the network's activities, drafted by the Secretariat, with a view to reflecting the activities of the network and cooperation among members and to taking credit with respect to the sponsors of EuroMeSCo's activities
- to establish the annual work and financial plans of EuroMeSCo and submit them to the General Assembly
- to submit to the General Assembly member or observer applications, based on reports on applications provided by a member of the network
- to appoint an Executive Committee and, if necessary, provide it with mandates.

No other business being raised, the meeting was closed at 12.30pm on 6 October 2011.
