While acknowledging the safe receipt of your letter of 7 November 2018 and the mail of the 1 November 2018, we would like to share with you the following.

MEMBERSHIP APPLICATION

The Anna Lindh Foundation Secretariat has no active role in the membership process which, on the other hand, is executed by the Head of Network of the concerned Country. The ALF Secretariat checks the application of new members is dully filled in without entering into any assessment. The decision of accepting new members as well as the management of the members (e.g. reconfirmation, internal rules etc.) is the exclusive role of the Head of Network.

Therefore, all the letters attached to your letter of 7 November 2018 and the ones attached to the mail of 1.11.18, will be forwarded to RIDE-APS— Head of Network of Italy since 16.09.2017 - and to the Ministry of Foreign Affairs, noting that the template for membership reconfirmation has been modified and they have not been addressed to the Head of Network. They seem, on the other hand, to be confirmation of a membership internal to the Federazione Anna Lindh Italia Onlus. Anna Lindh Foundation Secretariat will, in any case, proceed in forwarding these reconfirmation letters to the concerned parties — RIDE-APS and the Ministry of Foreign Affairs.

Regarding your request of exempting the individual members of the Federazione Anna Lindh Italia Onlus from confirming their membership to the Italian Head of Network, it should be highlighted that this request has to be addressed to RIDE-APS to verify the possibility and the modality of granting the requested exemption against the National Internal Rules provisions.

HEAD of NETWORK

The Head of Network, either elected or appointed, is endorsed by the Ministry of Foreign Affairs of the respective Country. The Ministry of Foreign Affairs of Italy has endorsed and notified RIDE-APS being the Italian Head of Network as of 16.09.2017.

The Anna Lindh Foundation Secretariat will forward your request (e.g. Co-head) to the Ministry of Foreign Affairs which is the only entity accountable for addressing, analysing and eventually satisfying your request.

With regard to this, please inform whether you do authorize ALF to transmit to the MFA of Italy your letter of 7 November 2018.

It should be highlighted, once more, that the existence of co-heads of Network in other national networks has been approved and endorsed by the respective Ministry of Foreign Affairs.

Anna Lindh Foundation Secretariat recommends once more your organization to get in touch with the Ministry of Foreign Affairs, specifically the department in charge of; while ALF will transmit copy of your correspondence (e.g. reconfirmation membership letters and, if authorized by you ,your letter of 7.11.18). Anna Lindh Foundation Secretariat will contextually ask for the Ministry of Foreign Affairs to scrutinise the membership management process which resulted in a significant reduction of network members. ALF will ask for having a report where the process undertaken is outlined and reasons for rejections are clarified and provided.

Anna Lindh Foundation will advocate once more for a meeting where the parties involved are present as well as the Secretariat of ALF in the capacity of observer/facilitator.

I hope we can all work together in a co-operative manner to find a satisfactory solution for all parties concerned.
