Rabeea Najm Al-Din Al-Nasser is the Founder and manager of House of Tales and Music (HTM). HTM was founded three years ago, bringing storytelling, music, singing, painting and handcrafts to all the kids and youth visiting.

HTM aims to support children affected by conflict, poverty and deprivation by providing them a safe space to express themselves and discover the world around them through stories and arts. It has organized and delivered workshops for more than 3,000 children from local refugee camps, and have trained 50 librarians working in 3 refugee camps in Irbid and Amman. The candidate is also the founder of 'Storytelling and Music Mobile Bus,' an initiative to reach out to underprivileged children in refugee camps and villages aiming at providing fun learning activities for children.
