# Advisory Council Meeting 2016

# Agenda and Information

#### Venue/Timing

The Advisory Council Meeting for 2016 will be held in Rome, Italy, on 8<sup>th</sup> September. Hosted at the Ministry of Foreign Affairs ("Sala Nigra"), the main meeting will run from 9.15am to 4.15pm, to be followed by a special dialogue conference (4.45pm-7pm).

#### Format

The internal meeting agenda for 8<sup>th</sup> September will be structured around: (a) an opening exchange on the regional context; (b) a morning work session; (c) an afternoon session on "amplifying an alternative narrative"; (d) a roundtable dialogue event with academic partners and think-tanks.

The Advisory Council 2016 represents a central milestone in advancing the adopted strategy of the Anna Lindh Foundation ("Working Towards 2025"). Convened by the President of the Foundation, Elisabeth Guigou, and hosted at the Italian Ministry of Foreign Affairs, the theme of the meeting is on a renewed definition of intercultural dialogue to underpin the Foundation's forthcoming advocacy programme and respond to new openings for policy voice.

A year on from the communication policy adopted through the 2015 Advisory Council, the Anna Lindh Foundation has now been associated to a series of high-level communications and policy frameworks, among them: the new 'European Neighbourhood Policy' (ENP), UfM Ministerials on Development and Cooperation, first EU global strategy on 'International Cultural Relations', and the United Nations Resolution 2250 (the first resolution on Youth, Peace and Security). The Foundation has also established a far-reaching global network of partnerships, from the World Leadership Alliance-Club de Madrid, OSCE and World Bank Group to a pioneering partnership with Facebook headquarters.

All of this provides a platform for the Foundation to have a voice and assume its role as a reference point for intercultural dialogue in the new and emerging Euro-Mediterranean region. The Advisory Council 2016 will focus on the substance of the Foundation's role in this perspective, and how to leverage existing networks to build an alternative narrative to extremist discourses.

# The Road to Valletta: transforming intercultural dialogue into action

The Advisory Council meeting has been timed to take place on the eve of the Anna Lindh Foundation's MED FORUM 2016 (Valletta, Malta – 23rd to 25th October) and ahead of the first Maltese EU Presidency that has "Mediterranean" as a central theme (first semester 2017). The aim is for the Council to shape the central advocacy agenda and main messaging on to road to Valletta.

MED FORUM 2016 has been built on a far-reaching participatory process involving the Foundation's institutional and civil society networks, with an unprecedented level of applications through the Forum registration. This process has already generated more than 1100 'project ideas' and 'good practices', and led to the definition of 10 strategic pillars to frame the Forum debate, exchange and advocacy output. What underpins all 10 pillars is shifting the focus of Euro-Med cooperation to citizens and embedding a culture of dialogue with the next generation of intercultural players, whether through 'rethinking learning' around transferable skills of crosscultural communication and critical thinking, or 'intercultural cities' as incubators of cultural diversity and social innovation.

11:00 – 13:00 SESSION 1: TRANSFORMING PRACTICE TO POLICY IMPACT

Moderated by the ALF Executive Director, with a focus on how to leverage the new advocacy opportunities and platforms for the Anna Lindh Foundation to shape policies around a renewed intercultural dialogue strategy for the Euro-Mediterranean region.

Following the adoption of the new strategy in 2015, and the renewed policy impetus for intercultural dialogue, the Foundation is being asked to have a voice in the face of the major global issues. In the immediate-term, the ground has also been prepared to launch a next level of advocacy work focused on the cultural response to policy agendas related to security, migration, social cohesion.

This working session will analyse the anticipated milestones and opportunities, from Med Forum 2016, the expansion strategy for Young Mediterranean Voices and the forthcoming Intercultural Trends Report to the Maltese EU Presidency and the G7 in Sicily (first semester 2017). The session will also aim to define with clarity the intercultural dialogue mandate today in the face of the new Euro-Mediterranean social realities, and as a basis to the central messaging which will be driven through the Forum and as part of a wider advocacy strategy of the Anna Lindh Foundation.

#### 14:30 – 16:15 SESSION 2: AMPLIFYING THE ALTERNATIVE NARRATIVE

Moderated by the Head of The ALF Executive Office, this session will build on the morning session with a strategic focus on the role of the Foundation in generating counter-narratives to extremist discourses impacting on societies to the north and south of the Mediterranean.

During the last twelve months, the Foundation has implemented the communication policy defined through the 2015 Advisory Council process, with a particular focus on embedding processes and capacity within the Secretariat, leveraging institutional networks to raise name recognition among the main regional actors, building a far-reaching media network and partnership, and securing the approval and resourcing of the European Commission on the first comprehensive communication and media plan.

The tools, networks and policies are now in place to launch a sustained communication effort aimed at, on the one hand, reaching large youth audiences and citizens in diverse locations across the region, and on the other, 'breaking the ceiling' when it comes to engaging opinion-leaders and decision-makers. The working session will focus on the strategy, core messaging and operational milestones for implementing large-scale "counter-narrative" campaigns.

#### Roundtable: Redefining Intercultural Dialogue

On the occasion of the 2016 Advisory Council, a special dialogue event has been organised in partnership with the Institute for International Affairs (IAI), as founding member of the New-Med research network, and the Chamber of Deputies of the Italian Parliament that has now assumed the presidency of the Parliamentary Assembly of the Union for the Mediterranean (UfM).

The dialogue event, which will involve the Advisory Council members with around forty representatives of think-tanks, academic institutions and CSO networks based in Rome, will focus on the theme of "Redefining Intercultural Dialogue in Time of Crisis and Change: A Mediterranean Perspective". The event will be moderated by the honourable Khalid Chaouki, chair of the culture commission of the UfM Parliamentary Assembly, with a key-note speech of the Anna Lindh Foundation President presenting the preliminary outputs of the Advisory Council thinking and interventions from three renowned scholars of the New-Med Network on: "integration as a challenge for society as a whole"; "alternative premises for intercultural dialogue"; and "a renewed definition of collective identity".

#### **CLIMATE IN ROME**

In September, the weather continues to cool down in Rome, Italy, although the city is still pleasantly warm. During the month of September, the average temperature is of a high of 27°C and a low of 15°C, with possibility of rain.
